

OSOM ACCESS AUTHORISATION OPERATING CONDITIONS

The following conditions apply to all over size, over mass (OSOM) access applications for Class 1 vehicles. An authorisation may include additional conditions depending on the vehicle, its load or the proposed travel route.

- 1. Non-compliance with any of these conditions will render the authorisation null and void.
- 2. This authorisation shall operate as specified in these authorisation conditions and shall be deemed to apply only to the movement of the vehicle/load when operated in excess of the regulations on length, width and height in the *Heavy Vehicle (Mass, Dimension and Loading) National Regulation 2013* for journeys on the routes or within the areas specified in the authorisation.
- 3. The authorisation shall not be deemed to be a waiver by Port Stephens Council of the right to recover from the applicant or responsible operator or his successors or assigns the cost of repairing damage to any road, bridge, culvert or causeway, overhead structure or other infrastructure by the operation of the vehicle referred to in the application.
- 4. At the discretion of Port Stephens Council, an applicant vehicle and its load may be required to be inspected by authorised officers or police prior to commencement of travel. If the vehicle or load is deemed unfit for travel, then any authorisation issued may be withdrawn and travel prohibited until the vehicle or load is re-inspected and declared fit for travel.
- 5. Port Stephens Council may charge a fee in addition to the NHVR fee to:
 - Assess an application, whether or not an authorisation is issued; and
 - Inspect an authorised vehicle and its load prior to travel.
- 6. The authorisation is issued subject to compliance with the load limits provided for in the *Heavy Vehicle (Mass, Dimension and Loading) National Regulation 2013.*
- 7. The authorisation and these Operating Conditions must be carried in the driving compartment of the vehicle at all times when the vehicle is operated in excess of the dimension limits provided for in *Heavy Vehicle (Mass, Dimension and Loading) National Regulation 2013.* The authorisation and these Operating Conditions shall be produced when requested by an authorised officer of Council, Roads and Maritime Service or the NSW Police.
- 8. Where the nominated route on the application requires travel on any road or structure owned or maintained by a controlling authority other than Port Stephens Council, consent must be obtained from that controlling authority before travel can commence over that road or structure. (Examples of controlling authorities include, but are not limited to, local councils, railway operators and waterways authorities.)
- 9. Where the laden height of a vehicle and its load exceeds 4.6 metres measured from the ground, the transport deck height must be reduced as much as is practicable before an authorisation to exceed the 4.6 metres overall height will be issued. A more appropriate vehicle may need to be used, at the discretion of Port Stephens Council.

- 10. Where the laden height of a vehicle and its load exceeds 5 metres measured from the ground, authority to travel under overhead lines must be obtained from affected utility supply authorities. It must be carried with any authorisation issued and must be complied with.
- The authorisation may be cancelled or revoked at any time by Port Stephens Council at its discretion.
- 12. The authorisation is NOT transferable in the event of change of vehicle ownership.
- 13. This authorisation does not apply for travel on any road to which a special limitation is applicable.
- 14. The vehicle described in the application must remain fitted with pneumatic tyres on all wheels unless specifically exempted. A tracked (metal or rubber) vehicle cannot be driven on roads in New South Wales, unless specifically exempted in writing by all relevant road managers.
- 15. Unless otherwise stated in the authorisation, all the conditions herein and the conditions within the *Heavy Vehicle (Mass, Dimension and Loading) National Regulation 2013* (as amended from time to time) shall apply to the vehicle.
- 16. If the application is required to be referred to the NSW Police Force for any additional travel conditions, the written advice received from the NSW Police Force must be attached to, and carried with, the authorisation.
- 17. The authorisation is issued subject to the condition that the relevant utility supply authorities (phone, power, gas, water etc) are advised where necessary of the vehicle dimensions and proposed route.
- 18. If a vehicle's proposed route includes travel on a private road, the applicant must obtain consent from the controlling entity prior to travel.
- 19. The applicant must not damage, remove or otherwise interfere with any road sign, notice or barrier erected for the purpose of regulating traffic in connection with roadwork etc. in accordance with s115 of the *Roads Act 1993*. Penalties apply.
- 20. Acceptance of the authorisation by the applicant or his authorised agent shall be deemed to be acceptance of this and the foregoing conditions.
- 21. In the event that the nominated trailing unit that is identified on this application becomes unserviceable or otherwise unusable, an equivalent configuration and capacity trailing unit that is roadworthy and currently registered may be substituted for the nominated trailing unit without the need to amend the authorisation document.
- 22. Pilot and escort vehicles shall be used in compliance with the attached OSOM Pilot and escort vehicle matrix.



*Additional pilots may be required in applicable notices. Please check the notice for details. **A Transport Management Plan is also required for all OSOM movements that travel on a 'high risk' route or involve the transport of a 'critical /sensitive' load.
