Roads, Nelson Bay – Request for improvements to pedestrian safety

Requested by: Port Stephens Council

File:

Background:

Council has been successful in obtaining a funding grant under the Australian Government Black Spot subprogram, for pedestrian safety improvements at Fly Point and Little Beach, Nelson Bay. The approved funding is for the installation of:

- kerb blisters,
- raised threshold and pedestrian crossings (wombat crossings),
- High Pedestrian Activity Area (HPAA) with traffic calming,
- slow point, raised threshold / horizontal deviation at mid-block location and conflict points (intersections and pedestrian crossings)

Pedestrian /vehicle crashes have been recorded in the location proposed for the HPAA. The one-way section of Victoria Parade has seen many requests to Council for improved safety of the on-road walking and cycling, painted shoulder with moderate vehicle speed appearing to be excessive.

Physical separation and speed reduction in this confined area will benefit both cyclists and pedestrians.

Council has received numerous complaints regarding the Beach Road area to the east concerning speeding traffic and anti-social behaviour adjacent to the heavily used park and boat ramp areas.

Raised pedestrian crossings and staggered parking will change the road environment to support the reduced speed limit.

Comment:

Council has revised the proposed improvements from the initial concept, to include additional pedestrian crossings, to improve safety and connectivity for vulnerable road users.


Cr Arnott requested that extensive community consultation be undertaken by Council for this project, prior to a final design being endorsed by the Local Traffic Committee.

Roads, Nelson Bay – Installation of 40km/h HPAA signs and markings

Requested by: Port Stephens Council

File:

Background:

In July of 2022, the Local Traffic Committee recommended various road safety improvements in conjunction with the introduction of a 40km/h high pedestrian activity area (40HPAA) to cover the Nelson Bay town centre.

Detailed design of the safety improvements for the Donald Street / Stockton Street intersection has resulted in changes to the previously recommended works. Drainage issues have resulted in the proposed raised platform at the intersection not being practical. As a result of community feedback, it is now proposed to instead relocate the existing Donald Street pedestrian crossing slightly to the west and to install an additional pedestrian crossing on the eastern side of the intersection. This will facilitiate safe pedestrian movement along the eastern side of Stockton Street.

Requested by: A business operator

File:

Background:

The business operator writes: "with the increase in the amount of busineses and cars / trucks parked in the area the street is becoming dangerous and there have been near misses - can the yellow lines be extended to give traffic a clearer view when entering the street?"

Comment:

As a heavy industrial area, a high proportion of traffic comprises heavy vehicles, including oversize and overmass vehicles. These vehicles require plenty of room to be able to safely negotiate intersections.



Avenue of the Allies, Tanilba Bay – Linemarking request

Requested by: A resident

File:

Background:

Council has programmed roadwork in Avenue of the Allies, Tanilba Bay. As part of the proposed work, linemarking is to be upgraded, including barrier lines at intersections, separation line and edge lines.

Comment:

The edge line will assist in keeping traffic off the shoulders and away from the edge beam thus reducing vehicular movement off the pavement. The road is also 800m long and straight. Linemarking to reduce lane widths will help to reduce potential speed issues.

Legislation, Standards, Guidelines and Delegation:

NSW Road Rules – Rule 132 - Keeping to the left of the centre of a road or the dividing line

Traffic control devices installed under Part 5.3 Div. 2 Road Transport Act 2013

Community Engagement

The recommended works will improve safety for road users and it is proposed that the community be informed of the Local Traffic Committee recommendation, once endorsed.

Discussion:

Cr Arnott raised concerns that a separation line would encourage overtaking in a '50' area. He instead requested that the separation line be changed to barrier lines.







Elkin Avenue, Heatherbrae - Request for installation of a pedestrian crossing

Requested by: A resident

File:

Background:

A local resident writes: "At the end of school days, students are released from the High School gates on Adelaide Street, and one teacher stands in the middle of the busy intersection on Adelaide Street / Elkin Avenue and directs 3 directions of traffic as well as buses performing u-turns from the bus bay (where cars are also often illegally parked) to try and get children safely across the road. Children often run between cars and it has been the sight of many near misses over the years."

Comment

Council officers have been in contact with the school and it is advised that teachers are no longer permitted to direct traffic. Instead, an allocated teacher stands on the footpath where they can safely direct students and assist with crossing the road in groups.

Background:

Council is proposing to extend the smart parking scheme at Nelson Bay, to include Laman Street and Victoria Parade at Fly Point.

Comment:

The metered parking restrictions are proposed to be 4P, similar to other waterfront parking areas, with exemptions for permit holders.

Tarean Road, Karuah – Pedestrian crossing facilities

Requested by: Cr Wells

File:

Background:

Cr Wells has received a request from the Karuah Community for a pedestrian refuge on Tarean Road, adjacent to the Wattle Street intersection. Now that a pathway has been added along Wattle Street, people cross the road from Mustons Road to access the new Wattle Street path, then on to Aliceton Reserve.

Cr Wells also requests that the marking and signage of the pedestrian refuge on Tarean Road Karuah, outside the Fish and Chip shop, be reviewed. The Community requests that line marking to be added on the approach to the refuge. The Community has also made comment that the 'S' bend of the refuge seems to be in reverse,

Comment:

Inspection Committee members noted that there is plenty of road width at the Wattle Street intersection, to allow for a pedestrian refuge.

It was also noted that the town centre crossing could be upgraded to a pedestrian crossing. Both locations would be good candidates for grant funding applications



Background:

Council has received a request from the contractor for the construction of the M1 Heatherbrae bypass, for the use of Camfield Drive, as an access route. The northern end of the bypass will pass behind Camfield Drive and it is proposed to access the site via Camfield Drive. There will be significant quantities of quarry materials transported by truck, to the project.

Comment:

Discussions between Council staff and the contractor have identified that the provision of centrelines and edge lines in Camfield Drive will assist with traffic movements and road safety. The contractor has also requested installation of 'No Stopping' adjacent to the access driveway



Sunset Boulevard, Soldiers Point – Request for one-way traffic flow

Requested by: A resident

File:

Background:

Council has received a request for one-way traffic flow at the northern end of Sunset Boulevard and for the eastern section of Resthaven Avenue at Soldiers Point.

Comment:

The request for one-way traffic flow is due to the narrow width of the roads. Buses, on numerous occasions cannot get through, as cars are often parked on both sides (particularly between Resthaven Ave and Ridgeway Ave). Buses end up reversing out and going up Resthaven. Resthaven Avenue is also very narrow, with parking for the reserve making it impossible for two cars to pass and vision is poor for vehicles reversing out of parking spaces. There is also overflow parking along the reserve from nearby units. Turning right, or even left, from Resthaven Avenue onto Soliders Point Road is difficult due to carks parked outside the shops making vision very poor. Cars are parked right up to corner at times.

Community Engagement

The requested changes will impact residents and visitors and it is proposed that the community be consulted as part of the Local Traffic Committee recommendation.

Discussion:

Traffic Committee members noted that one-way traffic flow would do nothing for the parking situation in Sunset Boulevard.

Committee's recommendation:

It was recommended that Council officers meet with East Ward councillors to discuss this request prior to undertaking any community consultation.
