# Koala Landholder Partnership Registration Competition

# **Terms & Conditions of entry**

- Information located on the online submission form regarding the purpose of the competition, how to enter and prizes form part of these Terms & Conditions.

# **Eligibility**

- 8. Entry is open to persons who meet the following criteria ("Entrant"):
  - a. you are an Australian resident, living in NSW;
  - b. you are over 18 years of age or have approval of a parent or guardian if under 18 years of age;
  - c. you have completed the Entry Form in its entirety and provide your name and contact details;
  - d. you are or have obtained landowner consent for the parcel to which the entry relates;
  - e. you are NOT:
    - i. a current or past employee of Port Stephens Council;
    - ii. a person who has accepted an offer of employment by Port Stephens Council; or



- iii. an immediate family member of any of the persons in the preceding two sub-paragraphs.
- 9. Persons who fall within the scope of 8(d) are not precluded from providing information to Council pertaining to Koala landholder partnership land parcels or locations within the Port Stephens region, at anytime, outside of the scope of this competition. Any information, material or photographs provided however will not be considered within the parameters of this competition and will render any submission invalid for the purposes of this competition.
- 10. Council may request that any Entrant at any time provide reasonable evidence that they meet the eligibility requirements listed above and failure to do so will result in disqualification from this promotion.

#### **Promotion Dates**

 The promotion commences on Monday, 9 October 2023, at 8am AEST and concludes on Thursday, 30 November 2023, at 5pm AEST ("Promotion Period").

#### **How to Enter**

- 12. To enter the promotion Entrants must during the Promotion Period:
  - a. complete the Entry Form via the Promotor's website;
  - b. provide their name and contact details; and
  - c. provide the physical address for the Koala Landholder Partnership land parcel or location, located within the Port Stephens Local Government Area.
- 13. Each submitted Entry Form that complies with the above criteria generates one entry ("entry") into the promotion. Only one entry is permitted per Koala Landholder Partnership land parcel or location within the Port Stephens Local Government Area.
- 14. The Promotor accepts no responsibility for any entry that is late, lost, incomplete, incorrectly entered or misdirected due to any technical difficulties or equipment malfunction (whether or not under the Promotor's control), including inaccessibility to the Promoter's website during the Promotion Period.



### **Awarding of Prizes**

- 16. A random electronic generator will be used to draw winning entries. The drawn entry must meet the Eligibility Criteria. In the event that the drawn entrant does not meet the Eligibility Criteria another entry will be drawn.

- 20. If a prize is not claimed by the Prize Claim Date, the Promotor will award the prize to another Entrant as per clause 16. The relevant time limits may be extended as convenient and in the absolute discretion of the Promoter.
