Cook Parade, Lemon Tree Passage – Request for accessible parking

Background:

The Local Traffic committee has previously recommended the installation of accessible parking at the medical centre and pharmacy in Cook Parade, Lemon Tree Passage. An access ramp has now been constructed but the proposed parking now needs to be relocated to match the location of the ramp.

Comment:

In order to meet the required standard for the width of accessible parking spaces (3.2m), parking would need to be removed from the opposite side of the road. This will result in the loss of 4 parking spaces.



Tuna Crescent, Fingal Bay – Request for parking restrictions

Requested by: PSC 586919

Background:

In a recent onsite meeting between Council officers and members of the Fingal Bay Community Association (FBCA), concerns were raised regarding the width of Tuna Crescent between Marine Drive and Short Street and that this posed a safety risk. The issue raised by community members was that the pavement width of Tuna Crescent makes it unsafe for buses and delivery trucks to access. The suggested mitigation measure put forward is to make one side Tuna Crescent a "No Parking" zone.

Comment:

It was noted that 'No Stopping' will also be required around the intersections.



Market Street, Fingal Bay – Request for parking restrictions

Background:

In a recent onsite meeting between Council officers and FBCA, concerns were raised regarding the manner in which delivery trucks are servicing the businesses on Market Street. The feedback provided suggested that delivery trucks are "stopping" to unload and making it difficult/unsafe for other vehicles to pass. It was highlighted that the additional traffic movements from the addition of the one-way arrangement are increasing this issue. The inclusion of this street within the smart parking network was also flagged as increasing the issue. A "No Parking" area has also been requested.

Comment:

It was noted that the narrow section of Market Street would benefit from 'No Parking' along one side.
