

Ferodale Road, Medowie – Extension of 'No Stopping' area at Wirreanda Public School

Requested by: PSC File: Background:

Council officers request an extension of the No Stopping zone on Ferodale Road, Medowie (the cul-de-sac end) opposite Wirreanda Public School.

The request is to extend the No Stopping restriction an additional 14 metres (to the School Zone reminder sign) to cover the area where the footpath leads pedestrians to the edge of the road.

During patrols, Rangers have witnessed a number of children nearly being reversed over by cars parked over the end of the path. Additionally, when vehicles drop off children in the No Parking area opposite, the children have been observed to run straight across the road towards the path.

Legislation, Standards, Guidelines and Delegation:

NSW Road Rules – Rule 167 – No stopping signs RMS signs database – R5-400 Traffic control devices installed under Part 5.3 Div. 2 Road Transport Act 2013

Discussion:

Council officers advised that the school had been consulted and were very supportive of the proposal. Cr Arnott requested that local residents also be consulted prior to the restrictions being extended.

Extend the existing 'No Stopping' area in the service road adjacent to Ferodale Road, Medowie, as shown on the attached sketch, Annexure A.



Lillypilly Close, Medowie – Request for parking restrictions

Background:

Council's Waste Collection contractor has raised an issue regarding Lillypilly Close, Medowie.

Recently, the residents have started parking cars and trailers at the eastern end of the Close making it hard for the garbage trucks to turn around.

Comment:

It was noted that the eastern end has become an outdoors workshop and parking area for residents. It was suggested that part-time 'No Parking' on the waste collection days, would suffice in disrupting the permanent parking in evidence.

Police comment: I note that on the western end of Lillypilly CI there appears to be sufficient room for a truck to reverse and turn around. On the eastern end of the road, if vehicles are parked it would create a problem for a truck to turn around. The installation of no parking signs would enable the garbage truck to freely turn around.

Approve the signage and linemarking plan, as shown on the attached sketch, Annexure A.




