Extend the 'No Stopping' restrictions in Paterson Street Hinton, as shown on the attached sketch, Annexure A.





# Background:

A local resident has requested changes to line marking, which currently allows overtaking along Ferodale Road at the intersection of Ferodale and Waropara Roads, Medowie. A vehicle recently overtook the resident heading west as he approached the intersection of Waropara Road. A car was exiting into Ferodale Road and was a near miss.


